Budgetary/Tax payments

Please note:
Initiating Budgetary/Tax payments is **not** supported via the EBICS channel
if **Beneficiary IBAN Account has "3" or "8" at position 13** of the BG IBAN then it is a Budgetary/Tax payment.

The applicable Budgetary/Tax payment details can be included in **Remittance Information as free text**. Some code words must be used, e.g. "/EIK/" or "/IZL/".

- Identification is **Mandatory** if beneficiary IBAN account has value **"8" at pos. 13**.
"/EIK/* + number of the payer" ; if payer is an **organization** ; Can be 9 or 10 or 13 digits.
"/EGN/ + number of the payer" ; if payer is a **person with Bulgarian Citizenship** ; Exactly 10 digits.
"/LNC/ + number of the payer" ; if payer is a **person without Bulgarian Citizenship** ; Exactly 10 digits.

- The following fields are all **Optional**:
"/IZL/ + Payer name" ; if the account owner is not liable; add the payer name after code word "/IZL".

*/BUL/ is replaced by /EIK/, but /BUL/ can still be used

Hybrid address

A new type of TAG59 is introduced: 59F. This tag supports a hybrid (mix of structured and unstructured elements) way to enter address data.
Full Unstructured addresses are no longer supported for SEPA and International payments after November 2026.
This means that, after November 2026, Unstructured addresses will be ignored
(Town name and Country are the minimum structured requirement)
In tag 59F each line starts with symbols that indicate the content of the line (between brackets).
Customers can add a maximum of 2 Name lines (1/) and a maximum of 2 address lines (2/).
In case 2 name lines or 2 address lines are provided, they will be concatenated(separated by a space) in the payment processing. The total number of lines can never exceed 5.
The last line (3/) contains the ISO Country Code and Town Name, separated by a forward slash.
